Jean-Philippe Trin has been appointed Chairman and Chief Executive Officer of ETDE, the Bouygues Construction subsidiary specialising in electrical contracting and maintenance.

In January 2000 he was appointed CEO of VSL International and Intrafor in 2001. Mr Trin was named Chairman and CEO of VSL International and Chairman and CEO of DTP Terrassement in March 2004. He is also Board member of the Ecole Spéciale des Travaux Publics.

Daniel Rigout has been appointed Chairman and Chief Executive Officer of VSL International and DTP Terrassement, the subsidiaries that constitute Bouygues Construction's specialist civil works division.
