COMPLIANCE STATUS

Bouygues Construction is in partial compliance with RGAA 4.0 at Double-A (AA) level owing to the non-conformities and derogations listed below.

TEST RESULTS

The conformity audit realised by <u>Ipedis</u> indicates that 68% of RGAA 4.0 Double-A (AA) level criteria are respected.

- 18 criteria not in conformity
- 40 criteria in conformity
- 48 criteria not applicable

INACCESSIBLE CONTENT

The content listed below is inaccessible for the following reasons.

Non-conformities

Several elements of non-conformity are described in this document, some of which recur over several pages:

- Links are not explicit (no relevant link or label text)
- Keyboard navigation is impossible because the location focused on is invisible.
- The menu and sub-menu are inaccessible by keyboard.
- The chat module is inaccessible by keyboard and by screen reader.
- There are additionally some violations of HTML best practices in the components of the pages audited.
- No H1 in the Publication page.
- Some contrast elements need reviewing: orange text on a white background and black or white text on an orange background.
- The filter available for choice of publications in the realisation page is not legible to screen readers or keyboard navigation.
- Download links for documents open a new window without informing users.
